Death toll rises to 10 in explosion
SAN CRISTOBAL: The death toll from a powerful explosion near the capital of the Dominican Republic rose to 10 on Tuesday as firefighters searched through smoldering rubble, authorities said. More than 50 people were injured in Monday's explosion at a bustling commercial centre in the city of San Cristobal, located just west of Santo Domingo. At least 36 of the injured remained hospitalised, according to Joel Santos, minister of the presidency. Local media reported that an additional 11 people are missing. AP

China threatened by flooding
BEIJING: A vast swath of northeastern China is threatened by flooding as at least 90 rivers have risen above warning levels and 24 have already overflowed their banks, state media reported Tuesday. Crews are standing by to defend homes and farmland across the Songliao Basin north of Beijing, which encompasses more than 1.2 million square km. The area includes parts of four provinces and several major cities with a total population of almost 100 million. Tens of thousands have already been moved to safety. AP

Poland showcases military might
WARSAW: Poland staged a military parade on Tuesday to showcase its state-of-the-art weapons and defense systems, as war rages across its southeastern border in neighbouring Ukraine and ahead of parliamentary elections scheduled for Oct 15. Crowds gathered in scorching temperatures expected to reach 35 degrees Celsius (95 degrees Fahrenheit) to see US-made Abrams tanks, HIMARS mobile artillery systems and Patriot missile systems, as well as South Korean FA-50 fighter jets and K9 howitzers. World leaders wish India on its 77th Independence Day

The leaders underline special, privileged, strategic partnership

Russian President Vladimir Putin, his French counterpart Emmanuel Macron, Australian Prime Minister Anthony Albanese and the US Secretary of State Antony Blinken underlined their "special", "privileged" and "strategic" partnership with New Delhi as they wished India on its 77th Independence Day on Tuesday.

In a message of greetings to President Droupadi Murmu and Prime Minister Narendra Modi on the occasion of Independence Day, President Putin said he is confident that the two nations will continue to boost fruitful bilateral cooperation in all areas through joint efforts, as well as constructive partnership in resolving pressing issues on the regional and global agenda.

"We attach great importance to our relations of special and privileged strategic partnership with New Delhi," he said.

Putin emphasised that



the achievements that India has made in the economic, scientific, technological and social fields are universally recognised.

"India enjoys well-deserved authority on the international stage, playing an important and constructive role in international affairs," he stressed, and wished happiness and prosperity to all Indians.

Congratulating the Indian people on their Independence Day, French President Macron in a post on X, formerly Twitter, said a month ago in Paris, "my friend @narendramodi and I set new Indo-French ambitions all the way to 2047, the centenary year of India's Independence."

"India can count on France as a trusted friend and partner, always," he tweeted in both English and Hindi, accompanied

by a video of Prime Minister Modi's visit to France last month.

In her Independence Day greetings, European Commission President Ursula von der Leyen said India and the European Union are "vibrant democracies".

"We both support wholeheartedly the rules-based international order and we are close allies in the fight against global warming. Our regions have so much to share. For the European Union, strengthening our strategic relationship with India is a top priority," she tweeted.

Extending "best wishes" to the people of India on behalf of the American people on Independence Day, US Secretary of State Blinken said as the world's oldest and largest democracies, America and India have created a strong bond that

grows ever closer as the two countries work together for a world that is open, prosperous, secure, stable and resilient. "On this momentous day, we reflect on the depth and breadth of our strategic partnership, and we celebrate the proud history of the Indian people, who are the key to the bright future we are building together," Blinken said.

"We stand with you in our shared commitment to tackle the most pressing global challenges to ensure the peace and prosperity of our people," he said, adding that last year has shown that the US-India relationship is deeper and more expansive than ever.

In his greetings to India, Australian Prime Minister Albanese said the "warm friendship" between Australia and India reflects the deep bonds between "our people" and his aim is to bring the two nations even closer together in the future.

"We will do that through the strength of Australia-Indian communities," he said in a statement.

Indian embassy in Nepal felicitates widows, kin of Gorkha soldiers on I-Day

The Indian Embassy in Nepal celebrated the 77th Independence Day on Tuesday by felicitating widows and next of kin of deceased Gorkha soldiers of the Indian Armed Forces and disbursing their dues worth NPR 53.3 million.

The celebrations began at the embassy premises in Kathmandu with the hoisting of the Indian national flag by the Indian Ambassador to Nepal, Navin Srivastava.

The ambassador also conveyed his greetings on the occasion to diaspora members in Nepal and video clips of President Droupadi Murmu's speech to the nation broadcast overnight were shown.

Widows and next of kin of deceased Gorkha soldiers of the Indian Armed Forces were felicitated by the embassy by disbursing their dues worth NPR 53.3 million (NPR 5.33 crore).

The celebrations witnessed renditions of patriotic songs and performances by the students of

Swami Vivekananda Cultural Centre of the embassy and Kendriya Vidyalaya, Kathmandu.

Nepal Prime Minister Pushpa Kamal Dahal "Prachanda" took to social media platform X, formerly Twitter, and extended warm greetings and best wishes to PM Narendra Modi and the "friendly people of India for continued peace, progress and prosperity".

Taking to X, Foreign Minister N. P. Saud wrote, "As India celebrates its 77th Independence Day, I would like to convey warm greetings and felicitations to H.E. @DrSjaishankar, External Affairs Minister of India. Wish Happy Independence Day

to the people and Government of India!"

Officials from the Indian Embassy, along with representatives from the government of Nepal and Chandragiri municipality, jointly inaugurated the Shree Bishnuvedi Secondary School's new building on the occasion. 'Prachanda' to embark on 10-day U.S. and China visit

Israeli President Isaac Herzog also conveyed his "warmest wishes" on the occasion to his Indian counterpart Droupadi Murmu and "all the wonderful people of India". "May our strong friendship and cooperation continue to strengthen and prosper," he wrote on X.

Earlier in the day, in the presence of over 300 Indians, India's Ambassador to Israel, Sanjeev Singla, hoisted the tricolour and highlighted the "deepening ties" between the two nations.

India has emerged as Israel's second-largest trading partner during the last fiscal year, crossing the \$10 billion mark in bilateral trade for the first time, he underlined.

"To this end an MoU on industrial research and development cooperation was also signed between the two countries in May," the Indian envoy noted, stressing enhanced cooperation between the two countries.

Singla also touched upon discussions in the defence sector emphasising India's priority for indigenous defence manufacturing under

'Atmanirbhar Bharat' and invited Israeli defence industries to deepen their investments in joint ventures.

He mentioned a telephone conversation between the defence ministers of India and Israel during which they identified areas of collaboration in high end technologies.

Singla noted that there have been several high level visits from Israel to India this year, including that of the Speaker of the Knesset, Amir Ohana, Economy Minister Nir Barkat, and Foreign Minister Eli Cohen.

Lanka's main Tamil party calls for federal setup

President Wickremesinghe on Monday reiterated the party's commitment to a federal solution.
